# **Open Access Policy**

# Copyrights

 BioProcessing Journal (BPJ) retains the copyright to each article but grants authors generous open access usage privileges.

## **Reuse/Republication Rights**

- If authors wish to republish their articles elsewhere, they need to contact BPJ. Once permission has been granted, authors must include an acknowledgment statement that we will provide. Example:
  - Republished with permission. Expediting
     Clinical Batch Production of Viral-Vectored
     Vaccines and Gene Therapy Products.

- When portions of an article (e.g., a table or figure) are to be shown in other literature or PowerPoint presentations, they should include the article citation. Example:
  - Witcher M. Estimating the uncertainty of structured pharmaceutical development and manufacturing process execution risks using a prospective causal risk model (pcrm). *BioProcessJ*, 2019; 18. <a href="https://doi.org/10.12665/J18OA.Witcher">https://doi.org/10.12665/J18OA.Witcher</a>

#### **Article Changes at a Later Date**

 Post-publication article revisions will be handled by the BPJ production department (working with the master files). Examples of revisions include: new author affiliations and contact information. A fee will be charged for extensive changes.

## **Paper Copies/Article Reprints**

 Authors can make unlimited reprints or paper copies of the article PDF.  If the author would like to order high-quality reprints from BPJ, the production staff can work up the specs, obtain a quote from the printer, and invoice the author for prepayment.
Reprints will be shipped to the authors.

#### **Each Article Posted on BPJ Website**

 Each article PDF file will be made available for free downloading on the BPJ website.

## **Author Posting Rights of Electronic File (PDF)**

- Authors may post the finalized article PDF file to their website and distribute as they see fit (e.g., email to colleagues, etc.).
- BPJ does not offer indexing services such as Scopus, PubMed, ResearchGate, and Google Scholar, nor do we track journal impact factor. As an independent bioprocess technologyfocused publication, we have chosen to keep costs low for authors while granting the freedom to self-archive, share, and index their papers where they want.

## **Search Engine Optimization**

- All articles are added to the DOI® (digital object identifier) System and CrossRef citation-linking network.
- BPJ will make the full article text and selected keywords visible to website metadata crawlers, which will facilitate effective search engine optimization and web browsing—all designed to help scientists worldwide find the articles.
